Thank you for your interest in the National Bar Association Judicial Council's Judicial Clerkship Program. The mission of the program is to pair African-American Judges across the country with highly qualified racial and/or ethnic minority 2L and 3L law students during the 2023 spring term (from March to May) for a minimum of 15 hours weekly, virtually or in person. The Judicial Council is implementing the clerkship program to provide minority law students an opportunity to learn about courts; witness firsthand how judges do their jobs and make decisions; watch experienced litigators present their cases; and increase the clerk's understanding of the law as applied in different types of cases.

The Judicial Council will award a minimum of ten (10) stipends in the amount of \$1,000.00 each to Judicial Clerkship Program participants. Completion of all portions of the application is required. The Scholarship Committee of the Judicial Council will interview and select the recipients. All decisions of the committee are final.

CRITERIA FOR SELECTION

- 1.Candidate must be a 2L or 3L law student at an ABA-accredited law school.
- 2. Candidate must be a member of a racial and/or ethnic minority that has been underrepresented in the legal profession.
- 3.Candidate must have a minimum G.P.A. of 2.5 on a grading scale of 4.0, or a 2.75 G.P.A. on a grading scale of 5.0.
- 4. Candidate must participate in an interview, if invited.

- 1. All portions of the application must be received by the Judicial Council deadline of Friday, February 20, 2023 5:00 PM EDT.
- 2. The application package must include cover letter, writing sample, resume, and transcript.

- 5. Applications not received in full by the application deadline will not be considered.
